MODELS OF DISABILITY

There are various types of models of disability; most popular are the Medical Model and the Social Model.

The Medical Model suggests that people are disabled because of their illnesses, impairment or medical condition, and as such the barrier they experience to equal access is due to this. Responsibility is placed on the individual to change and adjust to the normative society, in order to fit in.

The Social Model, however, suggests that a person is disabled because of the ways in which society is arranged. It places responsibility on wider society to change and accommodate to the differences that exists, stating that societal attitudes and infrastructure ought to make the necessary shift for equal access.

There are other important models of disability to be considered and/or scrutinised:



Charity Model

This views the person with a disability as a victim or someone to be pitied, which places the individual as a passive participant in life that requires constant care. It implies they have limited independence, and as such is the community's responsibility to know and decide what is good for them.



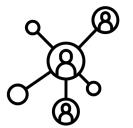
Eugenics Model

This model rests on the theory of eugenics which places people as 'fit' or 'unfit'. Those who are categorised as 'unfit' are then viewed as genetically inferior. The theory of eugenics is rooted in racist, classist, ableist, queerphobic, and sexist ideology.



Economic Model

This defines disability through the ability or inability to work and 'add' to the economy. It is focused on the productivity of an individual, and centres how much a disability prevents a person from working.



Biopsychosocial Model

This model looks at the interaction between the biological, psychological, and social factors, and how that affects an individuals experience.



Cultural Affirmation & Identity Model

This model stretches the Social Model of disability, and emphasises how the social and cultural factors shapes disability. It rejects the victimhood and catastrophising of disability.



Radical Model

This model views disability as a natural part of human diversity and as a result of oppression. It focuses on justice, utilising intersectionality as praxis.

DISABILITY BARRIERS

There are 4 types of barriers to consider:

Environmental

Lack of access

Communication

How information is received and shared

Organisational

Ways in which things are structured and arranged e.g., meetings, events

Attitudinal

Individuals fear, ignorance and assumptions



INTERSECTIONALITY

Intersectionality is the acknowledgment that everyone has their own unique experiences of discrimination and oppression, and we must consider how identities (protected characteristics and not) interact with one another to make up the lived experience of the individual.

Intersectionality is theory from US scholar, Kimberle Crenshaw, who coined the term to help highlight the experiences of Black women. This theory joins the family of concepts and theories that have long looked at how systems of oppression interact with one another. For example, 'Triple Burden' was a term coined by Claudia Jones which spoke about the interconnections of race, gender and class.

In her seminal paper, *Mapping the Margins: Intersectionality, Identity Politics, and Violence against Women of Color*, Kimberle Crenshaw denotes 3 categories of intersectionality for the reader.

Structural intersectionality

This looks at "...the ways in which the location of women of colour at the intersection of race and gender makes our actual experience of domestic violence ... qualitatively different than that of white women." (Crenshaw, 1991, p.1245)

Political intersectionality

This looks at how feminist and antiracists politics (as separate entities) can go on to further marginalise women of colour.

Representational intersectionality

This looks the "cultural construction" of women of colour (Crenshaw, 1991, p.1245).
